FINANCIAL CIRCULAR: SEPTEMBER 2024

Thank you for meeting your financial commitments to the school, even under challenging circumstances. Your compliance has enabled us to continue to provide our children with the quality education for which Destinatus is widely known in educational circles.

We want to express our appreciation to our Heavenly Father, every parent, staff member, and child who made positive contributions to the growth of our school. Destinatus salutes you.

Destinatus wishes all our valued parents and learners a prosperous last term of 2024.

1. SCHOOL FEES 2024

We would like to remind you of the following:

- 1.1. Please note that the financial obligations for 2024 must be met by 30 November 2024.
- 1.2. If you pay the full amount due for the 2025 school fees before 30 December, you receive a discount of 5%

2. SCHOOL FEES 2025

Registration fees, tuition fees, learning materials and learning and developmental aftercare centre fees.

- 2.1. Refer to **SCHOOLFEES 2025**, attached.
- 2.2. Learning-and-Development Aftercare Centre – kindly complete the holiday forms if you wish your child to participate in the holiday program, and indicate the dates that your child will be present.
- 2.3. If your child is absent, you are still responsible for the full amount since costs are incurred and meals planned and budgeted from the outset.

3. IMPORTANT POINTS FROM THE FINANCIAL POLICY

- 3.1. **For parties liable for payment of school fees** (including registration fees, tuition fees, learning materials and learning and development aftercare centre fees), refer to **Point 1 in Financial Terms and Conditions**.
- 3.2. **For terms of payment**, refer to **Point 3.3 in Financial Terms and Conditions**.
- 3.3. **For payments** - refer to **Point 4.1 in Financial Terms and Conditions**.
- 3.4. **For late payments and breach of contract**, refer to **Point 5 in Financial Terms and Conditions**.

- 3.5. **Cancellation of School attendance** (including tuition fees and Learning And Developmental Aftercare Centre fees, refer to **Point 12 in Financial Terms and Conditions**).
- 3.6. Should you decide to withdraw your child from Destinatus Private School, please send an email to the finance office, for attention Marlene Etzebeth, at accounts@destinatus.co.za and info@destinatus.co.za.
- 3.7. Please note the terms and conditions governing cancellation at 3.5. above, in concert with our Financial Terms and Conditions. The finance secretary will send you a cancellation form to complete and sign and return to both email addresses noted above. The reception date of your first email will serve as the effective date of cancellation.
4. **For clarification, please note:**

From the first day of the last term 2024 (LATEST – 1 OCTOBER) until 31 January 2025 the notice time is 3 months (90 days).

From 1 February 2024 until 30 September 2024 it is 1 month (30 days)

Example 1:

If notice is given that your child will leave Destinatus by the end of the school year 2024, written notice must be given by 30th of September 2024. If notice is given after 30 September 2024 and before 31 January 2025, you will be held responsible for payments for 3 months (90 days) after receipt of the written notice.

Example 2:

If written notice is received on 1 December 2024 that your child will not be attending school in January 2025, you will be responsible for payments for December 2024, January 2025 and February 2025.

Example3:

If your child is accepted for January 2025 and they do not show up, you will be responsible for payment of 3 months (90 days): January, February and March 2025.

5. **Method of payment:**

The management team strongly recommends that parents accept the stop order system as a payment method, as it is administratively the simplest system. Please arrange a monthly debit order, scheduled for the first day of every month, at your bank. No cash payments are accepted at school due to high risk and the safety of your child.

PLEASE USE ONLY YOUR CHILD'S FAMILY CODE (in the top right-hand corner of your statement) AS A REFERENCE.

When you receive an account / letter from the school, it is your duty to check it carefully and make sure that all personal details are correct, e.g. address, telephone numbers, etc.

You must also inform the finance office in good time when your child/children leave school.

If you do not receive an account, it is your duty to continue to pay school fees and inquire about the account. Failure to receive an account cannot be used as an excuse not to pay the

school fees. Contact the office (accounts@destinatus.co.za) if you do not receive an account.

Alleged payments not reflected in school records are deemed outstanding.

No payments for camps, fundraisers, or photos are to be paid into the school fees account. Please follow the payment guidelines issued for such additional payments.


